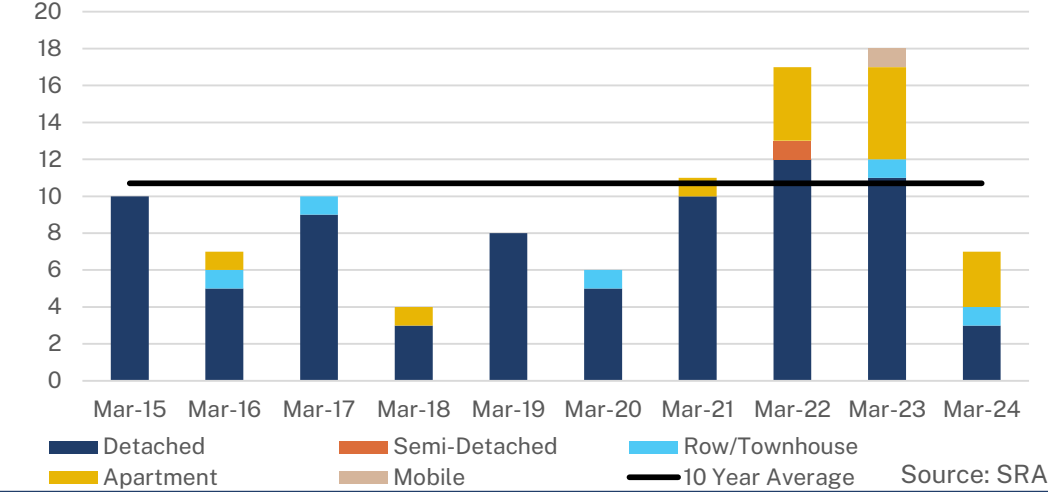

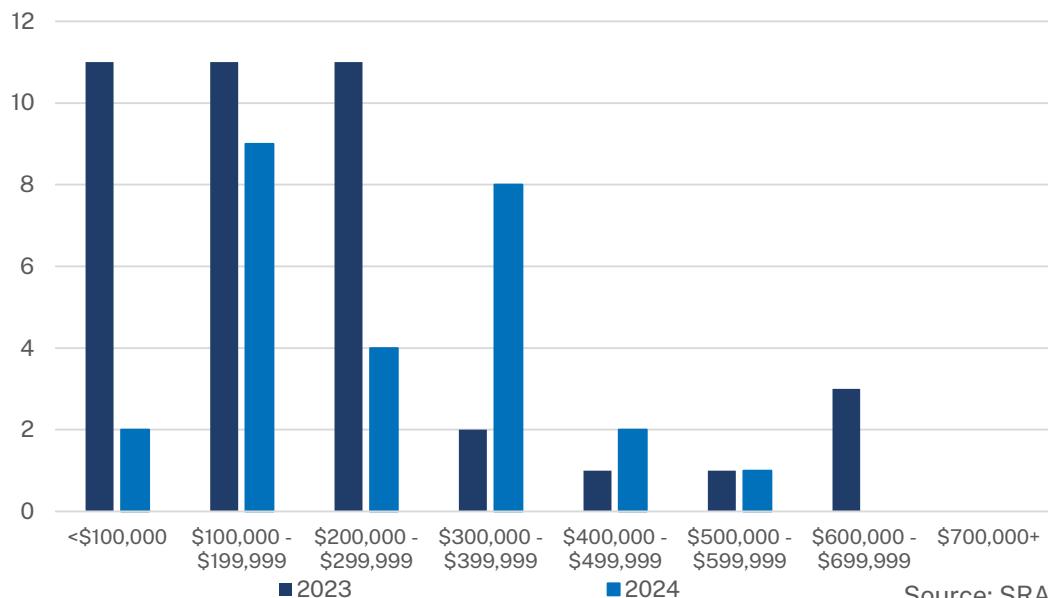

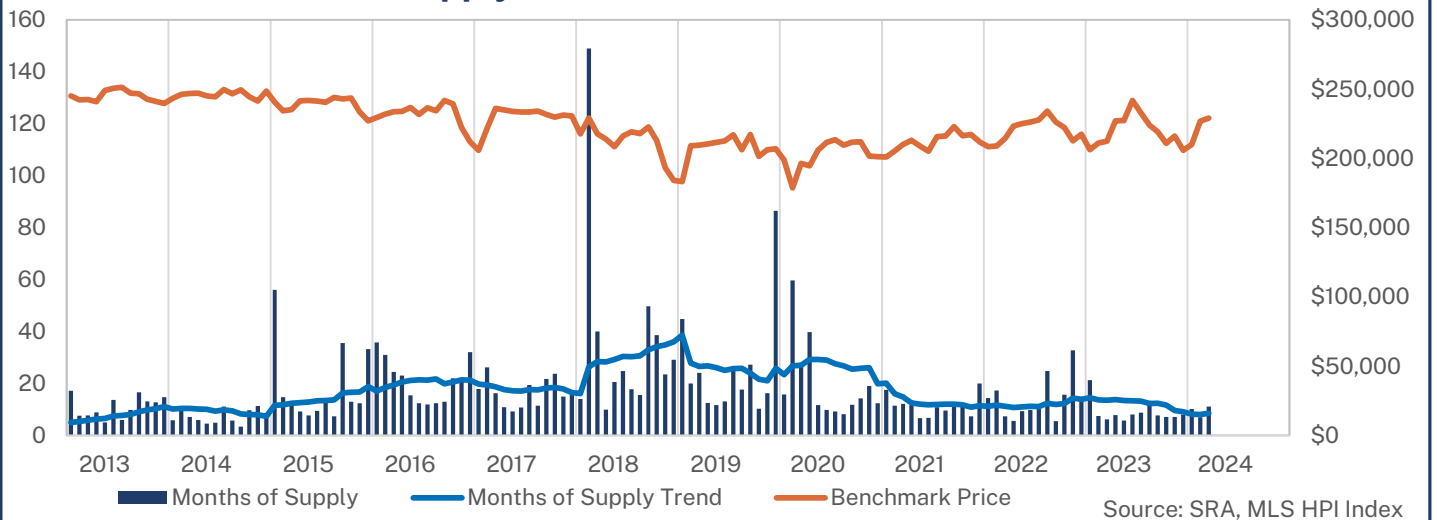

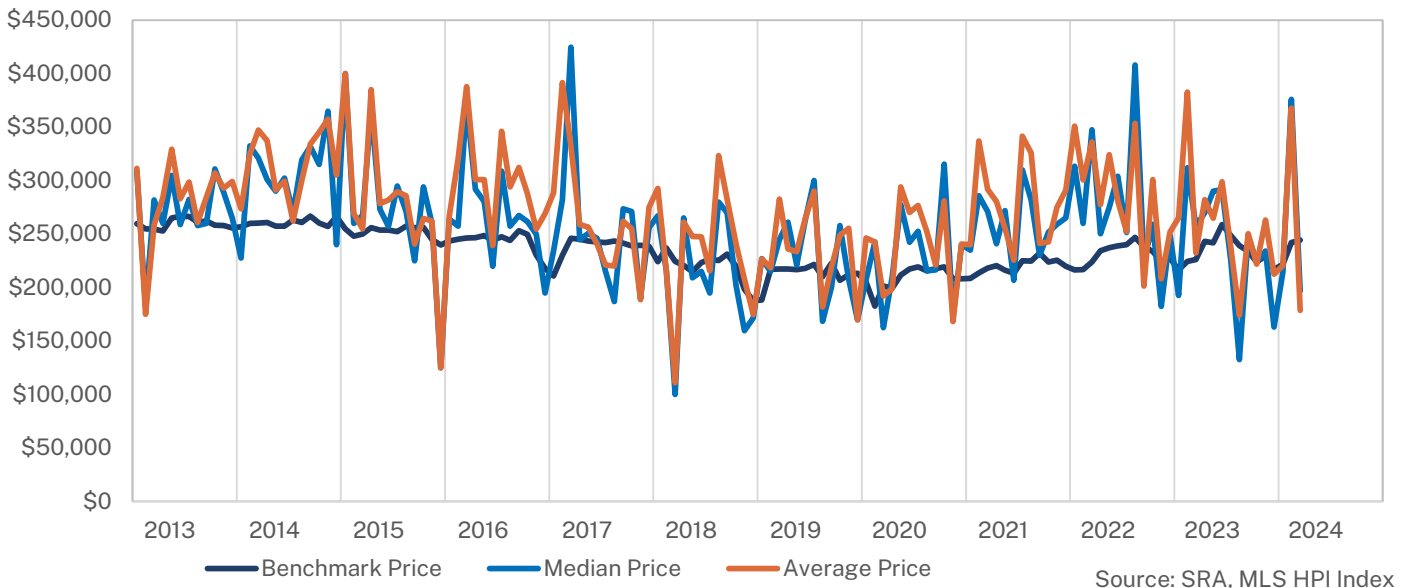
Residential Months of Supply and Price



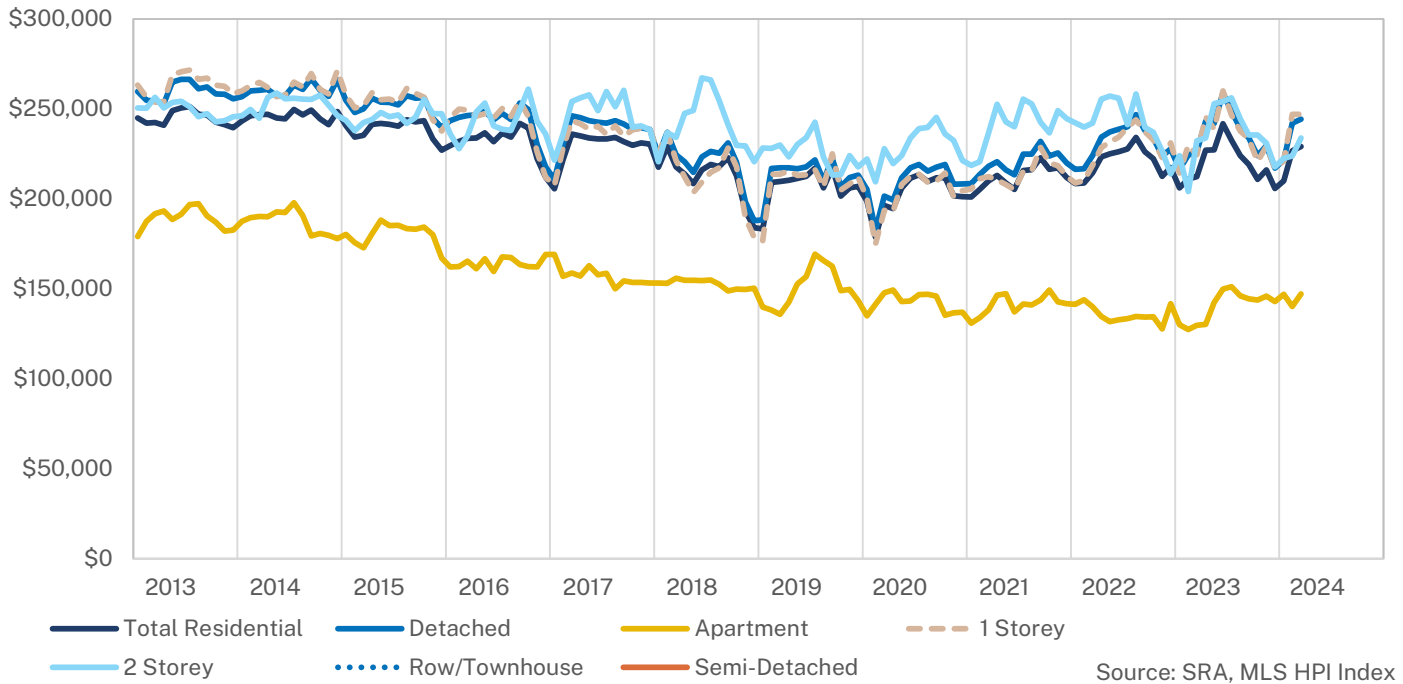
