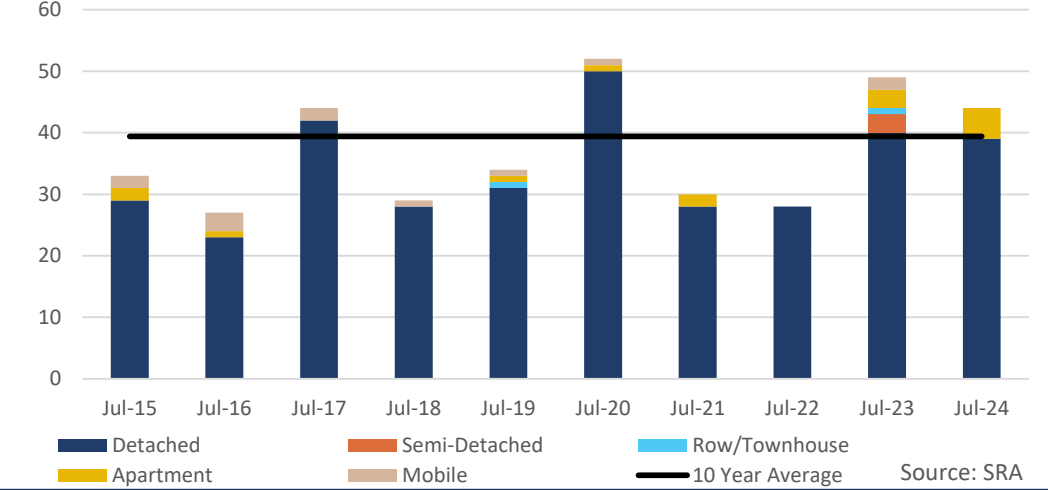

Monthly trend*



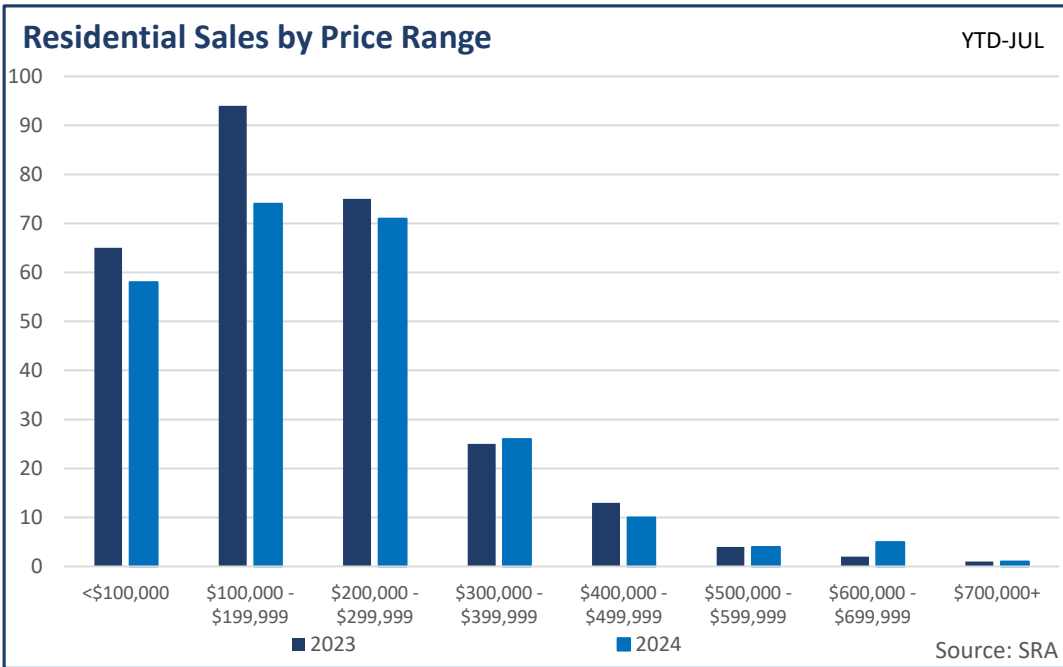

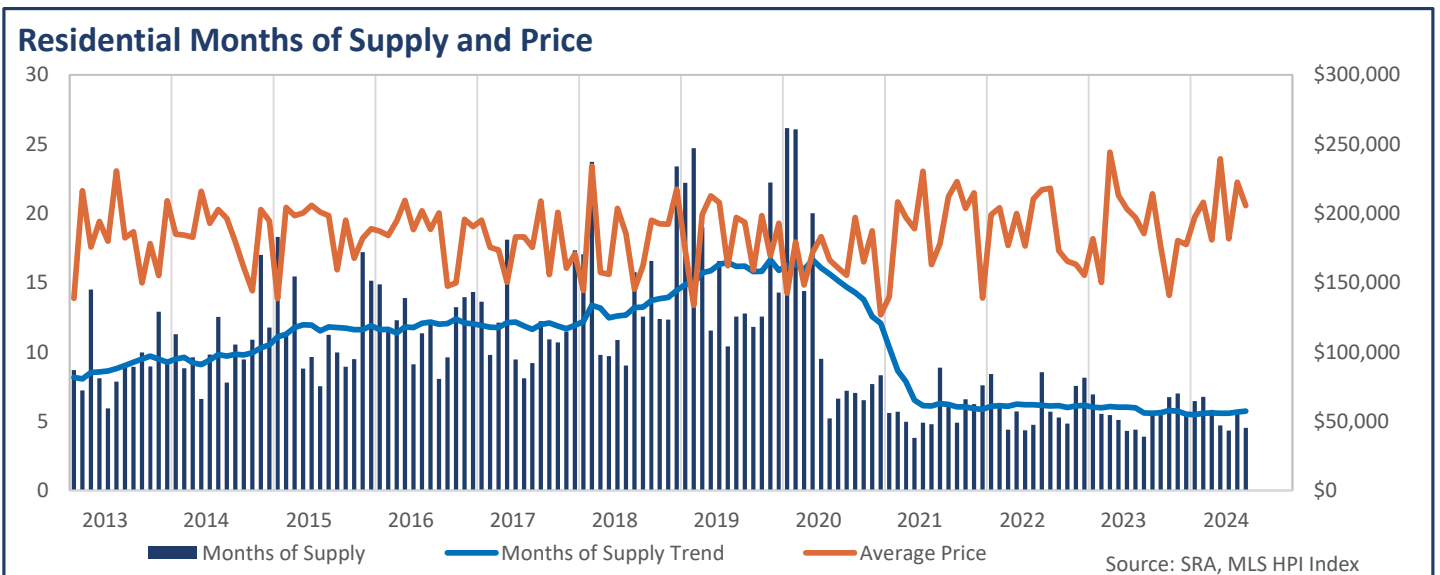
