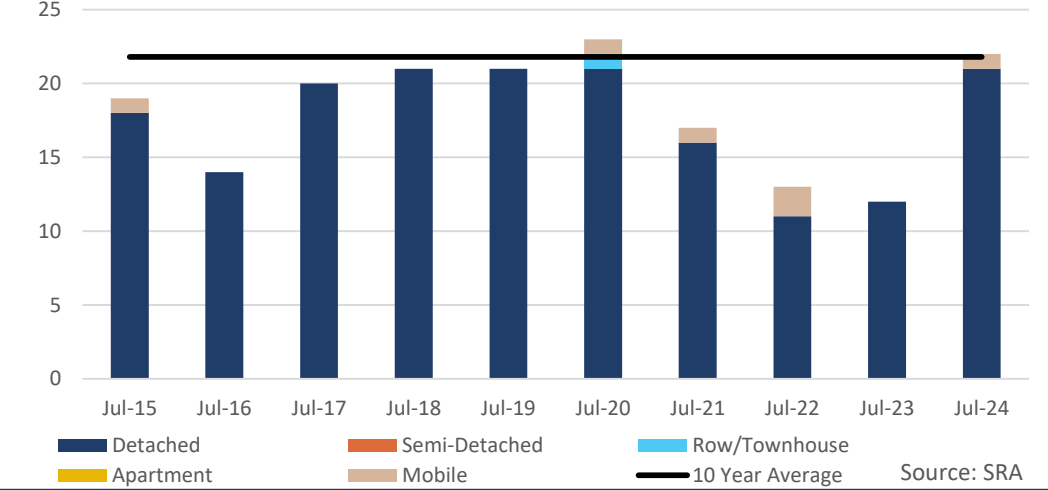

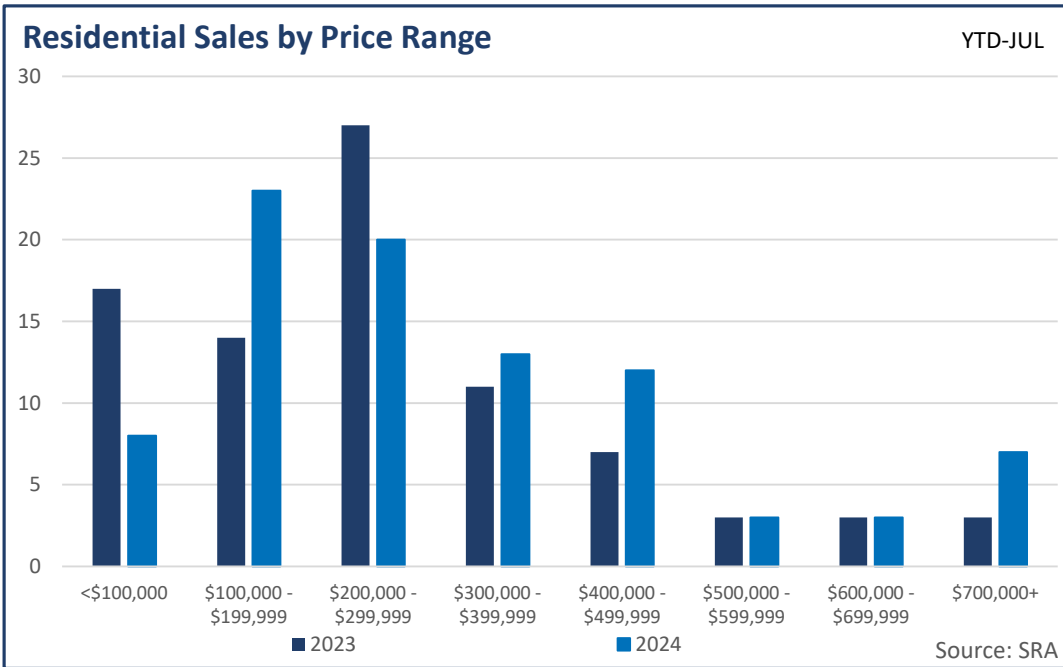



Monthly trend*

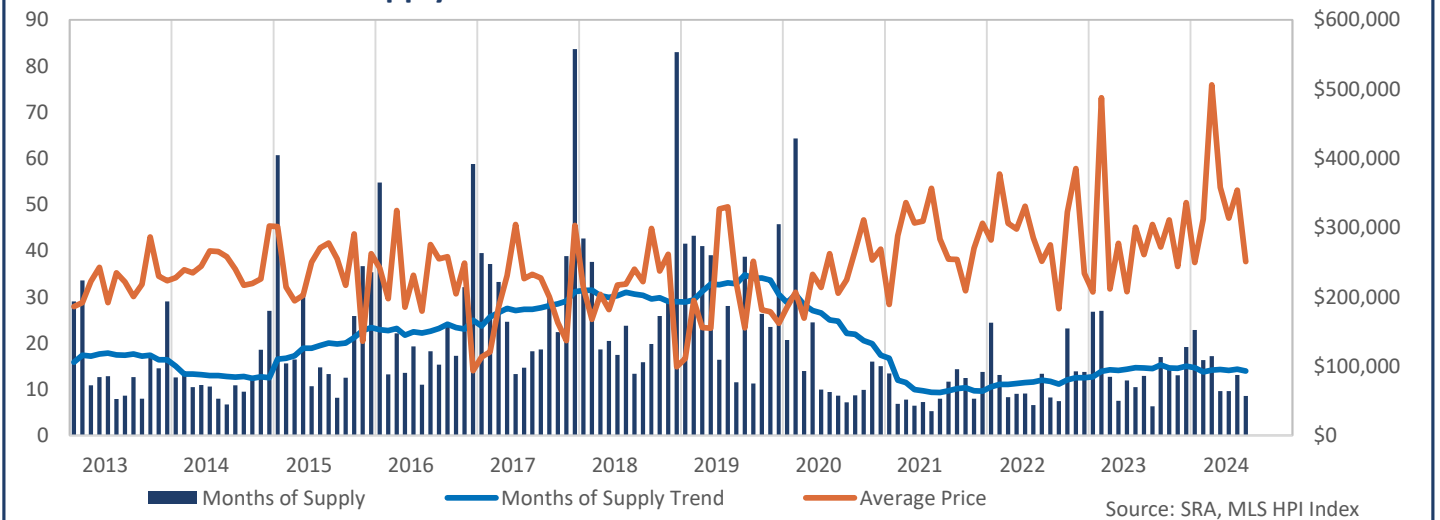
