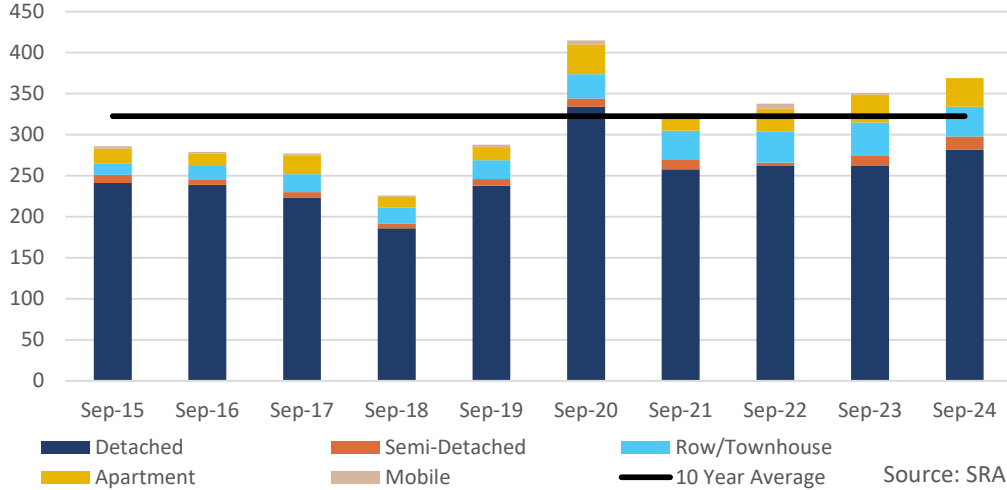

Monthly trend*

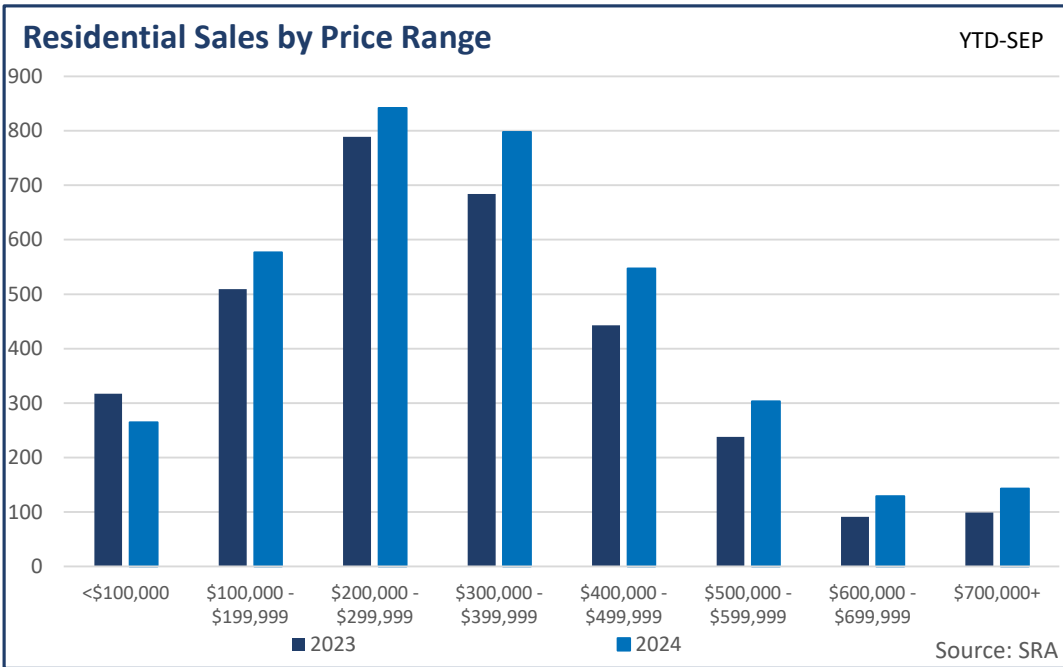

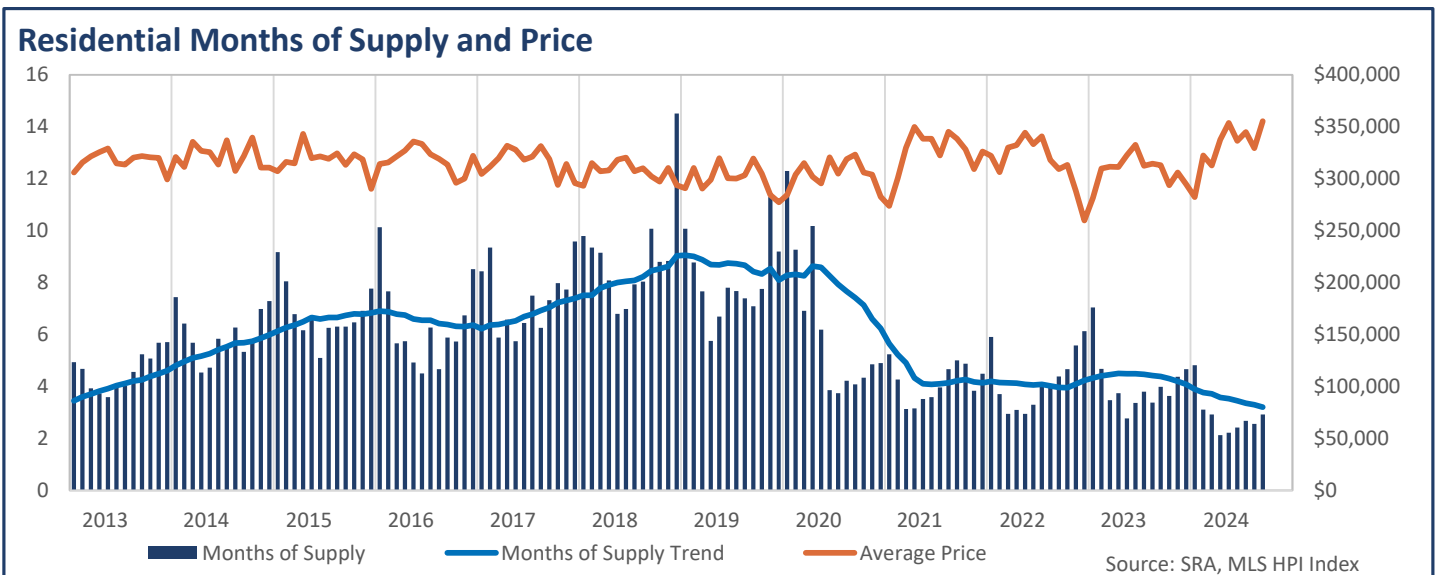
